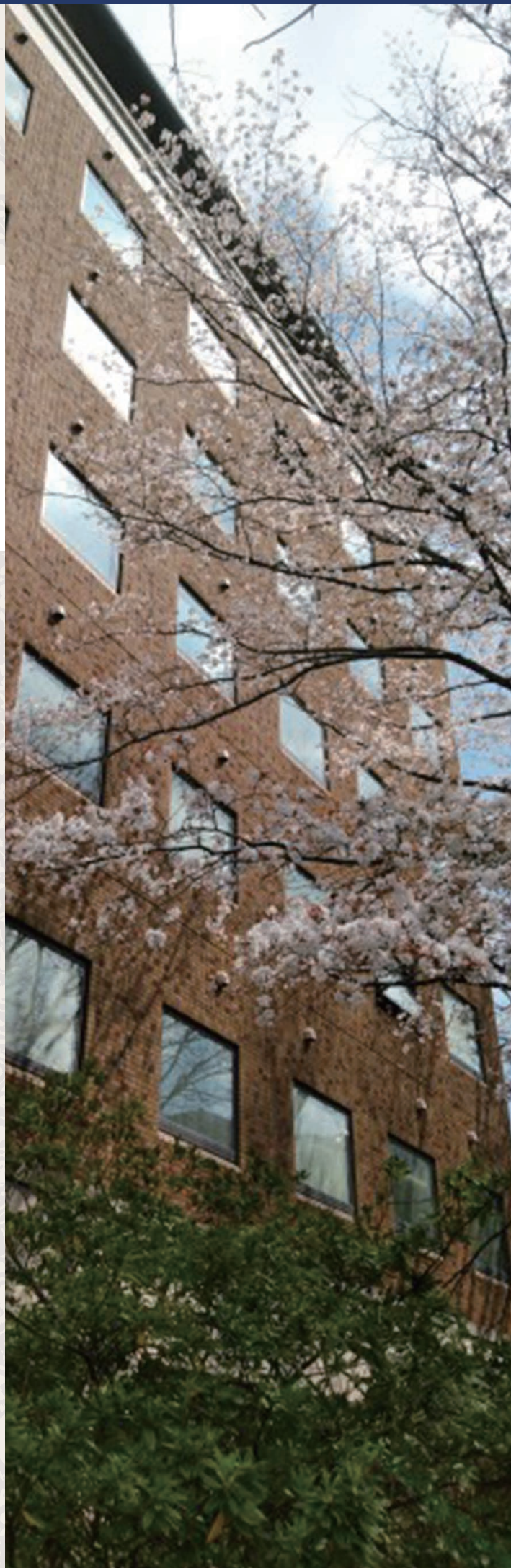

Introduction

The Institute of Business Law and Comparative Law & Politics (IBC) was established within the Graduate Schools for Law and Politics, University of Tokyo, in April 2006.

The IBC conducts its research activities through the two divisions of the BLC and ICCLP. The BLC carries out general theoretical and practical research on business law, and comprehensive research on the pedagogy of educating legal practitioners. The ICCLP promotes international research and education in the fields of Law and Politics.

The objectives of the IBC are to promote advanced research and collaboration among leading Japanese and foreign scholars and practitioners; to encourage the practical application of their research; and to promote research and education for the next generation of young scholars. The IBC undertakes these endeavours based on the three keywords of people, place and information: 'the creation of human networks', 'a place for research and exchange', and the 'dissemination of information'.

Under the guidelines indicated in "The University of Tokyo Activity Restrictions Index for Preventing the Spread of Coronavirus Disease 2019," IBC continues to carry out research and educational activities while exercising measures to prevent the spread of coronavirus infection.

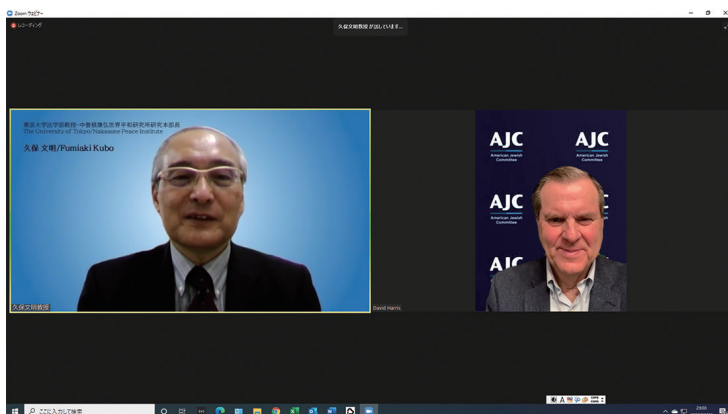

AJC was founded in 1906, and it is one of the oldest Jewish advocacy organizations.

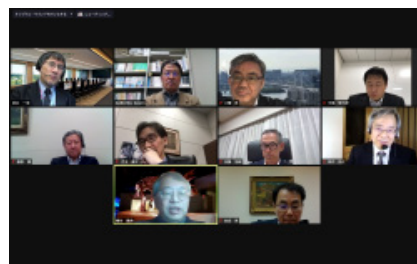

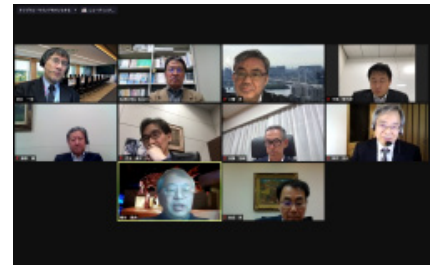

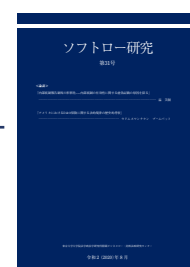
